

Line Item Amendments Prepared by the Bylaw Committee
Will be voted on individually, by the shareholders
Updated – January 17, 2026

- **ARTICLE IX:** These by-laws may be amended at any annual or special meeting where two-thirds (2/3) of all outstanding stock is present and passed by an affirmative vote of 50% (fifty present) + 1 share vote of all outstanding shares of CCDC stock.
- **HABITATS:** The Board shall be responsible for assuring that all CCDC habitats are maintained in accordance with the Habitat Replacement Plan. When a habitat review is conducted by the Bureau of Reclamation (BOR) one or more CCDC Board members shall attend the review. The CCDC Board shall assure that recommendations made by the BOR, in the Habitat Project Performance Report, are carried out in a timely manner. Let it be known that maintenance and upkeep of these habitats shall be borne by the shareholders of the Crawford Clipper Ditch Co., for the allotted time specified by the BOR, 50 years. To that end the Board may request that shareholders assist in the work necessary to help maintain the habitats. The Project 3, 4C Habitat Replacement Plan was signed on January 19, 2019 and the first planting was conducted the summer of 2020.
- **METERS:** *It is the responsibility of CCDC to develop a meter replacement and maintenance policy by 2030. Please note that meters carry a five (5) year warranty.*
We will now hold an open forum for the next 10–15 minutes *to discuss potential CCDC meter policies. This will remain an Annual Meeting agenda item over the next several years as we develop a formal policy(ies) and as meter technology continues to evolve.*
- **SUBDIVISION BYLAWS:** Any rule(s), statute(s), bylaw(s) or other regulation(s) developed by shareholder groups to manage/regulate CCDC water distribution, downstream of the CCDC main lateral outtake (meter or valve or splitter), shall not supersede the bylaws of the Crawford Clipper Ditch Co.
- **SUBDIVISION AND WATER RIGHTS:** If a property within the CCDC service network is divided, the home owners association or lost owners in the absence of a home owners association is responsible for all water distribution downstream of the existing pipeline outlet. No additional modifications will be allowed in the pipeline, once the pipeline is installed. If the subdivider sells or allocates water shares with any divided property, the subdivider must give advance notice to CCDC and release the original certificate to the Secretary. CCDC will be responsible for reissuing any stock certificates. If shares are to be held by a homeowners association, one certificate will be issued in the name of the homeowners association and the association shall appoint a single representative to represent the association at all CCDC meetings. Subdivisions/HOA's within the Clipper Ditch area of operations, at the time this amendment is ratified, will be not be required to change their existing management structure to accommodate this amendment, they will be "grandfathered in".
